

## REGULATION EURO ROUNDERS SEASON 2019



CAUTION IN CASE OF INCORRECT TRANSLATION THE REGULATION IN ITALIAN ORIGINAL LANGUAGE IS VALID

### ARTICLE 1 – COMPANY REGULATION

1.1 - Euro Rounders, organizer of the Euro Rounders Season 2019, proposes a calendar of events from December 2018 to December 2019 in the best European gaming venues.

1.2 - To participate in at least one of these THNL / PLO events it will be necessary to be more than 18 years, with a valid document (identity card / passport) and not having obtained a ban from the casinos and / or sponsors connected to the event.

1.3 - Participating in one or more of the events in the program confirms that you have read and accepted the regulation of the gambling venues that hosts the event.

1.4 - Each player paying the registration fee to any tournament of the Euro Rounders Season 2019 program confirms that he has read and accepted the Euro Rounders Season 2019 rules, which will be posted for the entire period of the events in progress, on the official notice boards of the houses from game hosting the various tournaments, also reachable at the site [www.eurorounders.com](http://www.eurorounders.com)

### ARTICLE 2 – PRIZEPOOL DISTRIBUTION

2.1 The distribution of the prizepool for each individual event will be proportional to the result achieved in each individual competition. The Tournament Director will make use of the changes he deems most appropriate based on the participants.

2.2 All tournaments with prize money guaranteed in the schedule include the 5% guaranteed prize pool in the form of "Tickets" to be played for a Grand Final tournament (excluding satellites), adopting the counting formula indicated in Article 4.

Ex: Tournament € 500.000GTD

PrizePool 475.150 + 71 GTD Tickets

2.3 In addition to the prizepool, when indicated on the official poster, at each tournament present in the schedule, 5% will be deducted from the prize money, then redistributed in the form of "Ticket Grand Final 2019" (from 06 to 17 December 2019) of the value of € 350 each.

Example 1:

TOURNAMENT THNL: BUYIN 640 + 60 / ENTRIES 1600 / TOTAL PRIZEPOOL 1,024,000 1st place € 300.000 + 1 TICKET GRAND FINAL

2nd place € 155.000 + 1 TICKET GRAND FINAL

3rd place € 90.000 + 1 TICKET GRAND FINAL

etc.

### **ARTICLE 3 - TICKET GRAND FINAL USE AND ACCUMULATION**

If a player had only one ticket available, the ticket can be used for the IPS Grand Final (from 06 to 17 December 2019).

In the event that the ticket holder does not show up at the IPS Grand Final 2019 Main Event, the right to use the ticket right will be extended exclusively to the first event on the calendar for the 2020 season, after which he will lose all rights acquired in the claim. No further extensions will be granted by Euro Rounders, excluding cases deemed to be serious by the organization.

In the eventuality a player obtains during the season more results that allow him to accumulate more than 1 Ticket Grand Final, he can not redeem or sell the ticket, but he will be allowed to use the economic value of each extra ticket to participate to other events during the 2019 or 2019 season. All tickets won in the Casino Perla Poker Room can only be used in the Casino Perla Poker Room, tickets won in other locations can be used in any casino that will touch the Premier circuit Season 2019.

Euro Rounders reserves the right to grant exceptions to the regulation only if it deems to be in front of cases or conditions deemed to be serious or of an extraordinary nature.

### **ARTICLE 4 - TICKET REINTEGRATION IN THE PRIZE POOL**

When indicated in the official schedule, at each tournament in the schedule, 5% will be deducted from the redeployed prize pool, starting from the first ITM until mathematically possible, in the form of "Ticket Grand Final 2019" worth € 350 each in addition to payout. In the event that it is not possible to deduct a sum such as to be able to complete the value of € 350, part of the deducted sum will be reinstated in the prize pool.

Ex:

BACK THNL: BUYIN € 640 + € 60 ENTRIES: 1600

GROSS PRIZEPOOL: € 1,024,000

VALUE 5% TICKET G.F. : € 51,200  
GENERATED TICKETS: 146 (value € 51.100) MONTEPREMI REINTEGRATION: € 100  
NET PRIZEPOLL: € 972.800 + 100 + 146 TICKET G.F.

## **ARTICLE 5 - RIGHT TO QUALIFY FOR THE GRAND FINAL**

5.1 - The player awarded the right to qualify for the Grand Final Season 2019 will have to fill out a form request data and keep the receipt that will be delivered and then present it in the box at the time of registration to the Grand Final (from 06 to 17 December 2019) .

5.2 - In the event that a player claims the legitimacy of having one or more appearances, the receipt issued during the course of the season will prevail, who will result in naive will lose all rights acquired.

## **ARTICLE 6 - TOURNAMENTS WITH MORE THAN ONE DAY2**

In all the tournaments promoted by Euro Rounders where more than a single Day2 is scheduled (meaning tournaments with at least Day2A and Day2B) it will be possible for players eliminated on Day 2A to register with the further Day1s without any limitation, according to the schedule.

Ex .:

In a schedule with Day1A - Day1B - Day1C valid to qualify for Day2A, in the eventuality a player is then eliminated at Day2A, he can play Day1D - Day1E - Day1F etc. as long as the Day1D - Day1E - Day1F etc. are successive in terms of calendar to Day2A.

This mode will be presented for the first time at Million 2019 on 11/23 October 2019. The procedure of this new mode will be a model for subsequent events.

## **ARTICLE 7 - EXHIBITION OF DISTINCTIVE MARKS AND SPONSORSHIPS**

Euro Rounders does not preclude its regulation, no form of prohibition in the exposure of brands and brands (even competitive), it being understood that such concession will be authorized within the legal limits of the organization and of the host game structure and regulatory system that complies with its local laws. In any case, any logo, image or message that at our sole discretion can cause any kind of reasonable offense, and / or contravenes moral, political, legal, ethical and other principles of various kinds, the organization will have full rights to request the effective and timely removal.

## **ARTICLE 8 - STAFF POLICY**

Euro Rounders does not grant any collaborators to participate in their events. In case of violation, the collaborator registered in the tournament without authorization will be immediately removed from the tournament and removed from the event itself.

## **ARTICLE 9 - DISQUALIFICATION FROM THE TOURNAMENT**

Euro Rounders, together with the host structure of the event, may disqualify any player, and / or visitor for any reason. Disqualification from the tournament does not justify any reimbursement of registration fees and any housing costs. The player is entitled exclusively to the payment of the prize, if eligible.

## **ARTICLE 10 - CAUSES OF FORCE MAJEURE**

In extraordinary cases of force majeure events independent of the organization, Euro Rounders will not be held responsible for all obligations due to the player and the event itself, such as the full payment of a guaranteed prize pool. For events of force majeure are all those events beyond our control, such as fires, floods, structural damage, earthquakes, adverse weather conditions, natural disasters, wars, strikes of the staff of the host structure and any other phenomenon out of the ordinary.

## **ARTICLE 11 - CHANGES AND ADDITIONS**

During the period in force of these Regulations, the organization, at its sole discretion, may make additions and changes to organizational and functional requirements. The Organization may also for unforeseen events or events, introduce changes and additions to protect and safeguard the order of the various tournaments, schedules and overlaps of events, but without prejudice to the spirit of the premises and the articulation of the event. Each scheduled event can therefore undergo changes in schedule, structure, buy-in. A scheduled event could also be canceled. If communicated before the registration to the Day 1 A a tournament with guaranteed prize money could undergo a modification, a reduction of the guaranteed prize or the cancellation. In the event of adverse weather conditions (eg snow or climatic phenomena that could block traffic) and / or in the event of transport strikes, current events could be postponed. In the event of traffic crashes due to accidents or

cataclysms, temporary border closure and similar phenomena, the schedule of an event may change even if the event is in progress. Any modification or integration will be announced through the [www.eurorounders.com](http://www.eurorounders.com) website in the News - Press section.

## **ETHICAL CODE**

The adoption of this Code has the primary objective of satisfying in the best possible way the expectations of our customers, our collaborators and our partners. aiming to recommend and promote a high level of professionalism and to prohibit behaviors that are in contrast with the values that Euro Rounders intends to promote.

The Code of Ethics is aimed at all those who establish direct or indirect relationships with Euro Rounders, in a stable or temporary manner, in particular by referring to our customers, our collaborators and all our partners.

The ethical standards of behavior that Euro Rounders intends to pursue are the following:

- equity and equality.
- diligence, transparency, honesty, confidentiality and impartiality during the course of our business
- protection of the person.

### **TV table regulation (Guidelines and Rules) TV TABLE**

The organization can integrate the gaming tables with an additional table called TV table, which can not necessarily be used only when the final table is composed, but can also be used during the tournament without limitation. The TV table does not change the rules of the game in any substance, to which the players must continue to stick with the utmost care.

### **COMPOSITION**

The composition of the TV table, in the case of a non-final table, is made in exactly the same way as any other non-television table, so the choice of players will be based on a random logic determined by the game rules.

### **ELECTRONIC DEVICES / CIGARETTES**

Players acknowledge and agree to deliver all electronic devices, in particular mobile phones, tablets, audio devices and accessories, which must be delivered to the staff. The material delivered will be deposited in a safe place and will be returned only during breaks or at the time of elimination from the tournament. No

exception. It is absolutely forbidden to smoke at the TV table, underlining that electronic cigarettes are also included in this ban.

### **BEHAVIOR**

During the TV table it is strictly forbidden to leave the table without the authorization of the tournament management, at no time the players can have contact with people outside the table. Even without the need to move away from the TV table, players can not communicate verbally with people outside and away from the table. This custom is strongly discouraged by the organization, which is entitled to remove at any time any person outside the TV table that is a constant cause of disturbance. Any form of behavior deemed inappropriate, both verbal and gestural, is to be considered a complete violation of the rules of the game, therefore any behavior considered as such will incur in penalties due.

### **AUTHORIZED STAFF**

The organization may have the right not to authorize any presence in the television room, except for the players, the TV operators, the managerial staff and the staff of the host structure, and / or in any case authorized by the tournament management itself.

## **PAUSE**

During the breaks, the players of the TV table, can leave the playing area, remembering that the return to the table will be bound by the clock, any delays of players when the TV table resumes, will be considered equal to those of a normal non-television table therefore, every complaint and / or observation will be considered void. The pauses of the TV table are regulated and organized by the technical direction of the competition, which will announce them to the players before the start and / or the shooting of the TV table. The breaks must take into account the technical needs related to television production, for this reason the organization has the right to modify them if it deems it necessary.

## **CARDS**

Players must place their own 2 cards in the appropriate RFID reading space, in case of non-compliance, the organization reserves the right to stop the game until such time as it is respected. In the event of continuous impediment by some players, the organization may request the removal from the table, until the moment when the player is not willing to collaborate in compliance with this rule.

## **NEW AGREEMENTS ON PRIZEPOOL REDISTRIBUTION**

All players must agree by mutual consent. Players can interact with each other to discuss any agreements on the redistribution of the jackpot. The organization and the managerial staff must be absolutely informed and present during the elaboration of the content of the new agreement, which can subsequently be made public and official.
